**Explicit Informed Consent** – I acknowledge that I have willingly agreed to have Jackgreen become my electricity retailer for this Premise. By signing this agreement I am verifying that I am over 18 years of age and authorised to change the electricity retailer for this Premise.

**Contract Termination** – I may cancel this contract without penalty by giving notice in writing within ten business days after the date of this agreement. If I otherwise terminate this agreement within [.....] months of Jackgreen commencing the supply of electricity to my property, or if I transfer my electricity supply to another retailer without providing written notification, I will incur a termination fee of \$49.

**Privacy Act 1988** – I give Jackgreen permission to retain my personal information on file to be used for the purpose of connection, supply and billing of electricity to my Premise.

**Transfer to Jackgreen** – My account will transfer to Jackgreen when my electricity meter is next read. This may take up to 90 days. Consequently, I will receive at least one more bill from my current retailer.

**Credit Assessment** – I understand Jackgreen may complete a credit assessment on all new customers and if I have an unsatisfactory credit rating Jackgreen may elect not to proceed with this agreement, or may require a security deposit.

**Authorised Representative** – I understand that the Sales Representative who co-signed the agreement is an Authorised Representative of Jackgreen. I understand that the Sales Representative may be paid a commission by Jackgreen. I have sighted the Sales Representative's Identification Badge.

**Rebates** - I understand that if I currently qualify for Pensioner or Life Support Rebates, then this will not be affected by the switch. I understand that I will need to provide the representative with my pensioner card number. I understand that I will need to provide Jackgreen with a medical certificate to be eligible for the Life Support rebate.

**Direct Debit and Centrepay** – I understand that there will be a \$2 transaction charge per month if I choose another payment option.

**Previous Consumption History** - I authorise my network operator to disclose to Jackgreen my electricity usage data for this Premise address for the 12 month period prior to my last meter read.
